The Local Government Unit of Binalonan, Pangasinan through its Bids and Awards Committee (BAC) Invites contractors to apply for eligibility and to bid the hereunder infrastructure project:

Name of Project: Construction of Fountain
Location: Poblacion, Binalonan, Pangasinan
Approve Budget for the Contract: Php 30,000,000.00
Contract Duration: 5 months
Source of Fund: General Fund - LBP Loan

Prospective bidders should possess a valid PCAB license applicable to the contract-**Small B** only, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/ Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bids.

All particulars relative to eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Opening Bids, Post Qualification and Contract shall be governed by the pertinent provisions of R.A. 9184 and its implementing Rules and Regulations. Prospective bidders should present original PCAB license for validation before issuance of bid documents.



Bid Documents will be available only to prospective bidders at the Office of the BAC Secretariat, Municipal Hall, Binalonan, Pangasinan, upon payment of a non-refundable amount of P 25,000.00 to the Municipal Treasurer as payment of Bidding Documents.


